8.3 Reduced Workload Program for 2017-18
As per the negotiated MTA Agreement, the District must declare by November 15th of each year whether certificated employees will be offered the reduced workload retirement option for the following year (2017-18). (action)

8.4 Adoption of Resolution 2016-17: Regarding the change of election day of the governing board and requesting the Board of Supervisors for the county of Mendocino to authorize consolidation with the November election during even-numbered years. (action)

8.5 Adoption of Resolution 2016-21: Adoption of the 2015-16 Actual and 2016-17 Budget GANN Limit Resolution. The Board is required to annually approve the calculation of the Gann Limit. While the Gann Limit calculation is not straightforward in logic or in purpose, it is a constitutional formality. Attached is a "Fiscal Report" by School Services of California that explains why the Gann Limit is calculated and what it means for our District. (action)

- 8.6 Authorization of certificated teaching assignments (action)
 - 8.6.1 Approval of 6th grade Science/Math teacher to be assigned to teach under a Limited Assignment Option under Education Code 44258.2 which allows the holder of a Single Subject or Standard Secondary Teaching Credential to be assigned to teach classes in grades 5-8 in a middle school if they meet specific unit requirements of the subject taught. Action of the governing board and teacher consent is required. (action)
 - 8.6.2 Approval of 7/8 grade Math teacher to be assigned to teach under a Limited Assignment Option under Education Code 44256(b) which allows the holder of a Multiple Subject or Standard Elementary Teaching Credential to be assigned to teach classes in grades 5-8 in a middle school if they meet specific unit requirements of the subject taught. Action of the governing board and teacher consent is required. (action)
 - 8.6.3 Approval of Variable Term Waiver Request through the California Commission On Teacher Credentialing which will allow a currently assigned teacher a waiver while she completes BTSA training. Upon the completion of BTSA, she will receive her clear credential which will include a required certification for SDAIE (Specially Designed Academic Instruction in English) a teaching approach intended for teaching various academic content using the English language to students who are still learning English. Board approval is required for this waiver. (action)
 - 8.6.4 Approval of a credentialed science/physics teacher to be assigned under a limited assignment option to teach chemistry. A valid teaching credential issued by the State Board of Education or the Commission for Teacher Preparation and Licensing, based on a bachelor's degree, student teaching, and special fitness to perform, shall be deemed qualifying for assignment as

- a teacher in the area of chemistry. No units are required up front, but 6 units of chemistry are required for renewal. Action of the governing board and teacher consent is required. (action)
- 8.6.5 Approval of a credentialed Special Education teacher to be assigned under a limited assignment option to teach pre-algebra. A valid teaching credential issued by the State Board of Education or the Commission for Teacher Preparation and Licensing, based on a bachelor's degree, student teaching, and special fitness to perform, shall be deemed qualifying for assignment as a teacher in the area of math. No units are required up front, but 6 units of math are required for renewal. Action of the governing board and teacher consent is required. (action)
